

**("Win Cashback with Shell V-Power")**

**TERMS AND CONDITIONS**

1. These terms and conditions including the general terms and conditions ("Terms and Conditions") shall apply to the **Win Cashback with Shell V-Power** Promotion ("Promotion") organised by Brunei Shell Marketing Company Sendirian Berhad ("BSM").
2. "Cashback" refers to a cash refund of the purchase amount in the form of fuel vouchers.
3. **Promotion Period**
  - (i) The Promotion shall commence from 12:00AM on 1 December 2024 to 11:59pm on 31 December 2024, both dates inclusive which can be changed by BSM without prior notice. Thereafter, no further entries will be considered unless otherwise expressly stated on BSM's official Facebook and Instagram account (@bruneishellmarketing).
  - (ii) The draw for 20 eligible participating winners will be held in the first week of January 2025 and will be announced the same week on BSM's official Facebook and Instagram account.

  - (iii) The Promotion shall only be applicable for Shell V-Power gasoline and Shell V-Power diesel customers with genuine receipts from the Authorised Merchants.

- (iii) Each participant is required to scan a QR code available on BSM's website at [www.bsm.com.bn](http://www.bsm.com.bn), Instagram and Facebook at @bruneishellmarketing and complete the online registration participation form ("Participation Form").
- (iv) Each participant must enter the following details:
  - a. Full name as per National Identity Card or Passport;
  - b. Date of birth;
  - c. Telephone number; and
  - d. Electronic mail (e-mail) address.

- (v) Each participant must keep their receipts from the Authorised Merchants in order to be eligible for the prize as proof of purchase.
- (vi) There is no minimum spend per transaction to enter in the Promotion.
