

**(“Shell V-Power Purchase with Purchase with Pokémon”)**  
**PROMOTION**

**TERMS AND CONDITIONS**

1. These terms and conditions including the general terms and conditions (“Terms and Conditions”) shall apply to the **Shell V-Power Purchase with Purchase with Pokémon** Promotion (“Promotion”) organised by Brunei Shell Marketing Company Sendirian Berhad (“BSM”).
2. **Promotion Period**
